

**MINUTES OF BOARD OF EDUCATION  
SCHOOL DISTRICT OF ARCADIA  
REGULAR BOARD MEETING  
AUGUST 21, 2017**

A regular meeting of the Board of Education of the School District of Arcadia was held in the high school room 219 in the City of Arcadia, County of Trempealeau, Wisconsin, on Monday, August 21, 2017. The meeting was called to order at 7:00 p.m. by Board President Loren Wolfe. Board members present were Loren Wolfe, Rodney Walters, Paul Servais, Randy Nilsestuen, Dana Conrad, Brian Steinlicht and Mike Edmunds. Also present were Andrew Dannehey, Louie Ferguson, Alan Herman, Michele Butler, Jackie Schira, Paul Halverson, Matt Vondehaar – Schneider Electric Representative, Dave Frahm, and JoAnne Wier.

President Loren Wolfe announced the verification and compliance with the open meeting law.

A motion was made by Dana Conrad and seconded by Paul Servais to approve the agenda. Motion carried 7-0.

President Loren Wolfe led the Pledge of Allegiance.

A motion was made to approve the July 17, 2017 closed session minutes and the minutes of the July 13, 2017 and the August 7, 2017 board retreats. Motion carried 7-0.

The July 17, 2017 open session minutes will be corrected and brought back to the September meeting for approval.

Louie Ferguson provided a recap of the building improvements seen on the tour.

A motion was made by Rodney Walters and seconded by Paul Servais to approve the retirement of Jane Thomas. Motion carried 7-0.

Paul Halverson, Michele Butler, Alan Herman, and Jackie Schira left at 7:54 p.m.

Louie Ferguson walked through the budget recap. Purchased furniture (approx. \$20,000), upgraded practice field (\$24,000), added money to fund 73 (\$75,000) plus added money to fund balance (\$22,586).

It was decided to have a special full board meeting to discuss the employee handbook revisions. Meeting is set for September 6, 2017 at 7:00 p.m.

Louie Ferguson led the discussion on the Challenge Academy and discussed the potential for a policy and will bring the new policy for approval in September.

Louie Ferguson led the discussion on the senior exit surveys. The board discussed the data and value of the survey.

Mike Edmunds led the discussion on the conflict of interest statement he created. The board discussed and an updated version will be provided to Louie so that he can submit it to the legal counsel for correct wording.

Louie Ferguson led the discussion on a grant writing position. The consensus of the board is for Mr. Ferguson to continue to pursue.

Louie Ferguson led the discussion on ALICE training update.

Louie Ferguson gave an update on the Trempealeau County Co-op 2.0. A full board meeting will be in Whitehall on August 31<sup>st</sup> at 7:00 p.m.

Loren Wolfe led the discussion on the middle gymnasium update.

Louie Ferguson gave his superintendent report. He is waiting on state budget before finalizing budget. He stated that salary increases and added staff are the major increases in the budget.
